## **ADJUDICATION OF INCAPACITY AND APPOINTMENT OF GUARDIAN FOR INCAPACITATED PERSON**

Upon hearing at which the above-named incapacitated person/protected person  was  was not present, or after legal opportunity for hearing, the Court finds that a qualified person has been presented to this Court to be appointed guardian of the named person; that venue is proper; that the required notices have been given or waived; that the named person is incapacitated; that if the named person did not attend the hearing, inquiry was made as to whether he/she wished to do so; that this appointment is necessary or desirable as a means of providing continuing care and supervision of the person of the incapacitated person, and that this appointment is necessitated by the named person's actual mental and adaptive limitations or other conditions, all as required by 18-A M.R.S. § 5-304.
