An order terminating parental rights divests the parent(s) and child of all legal rights, powers, privileges, immunities, duties, and obligations to each other as a parent and child, except that the child inherits from the child's former parent(s) of so provided in the order. The termination of one parent's rights shall not affect the rights of the other parent. A parent whose rights have been terminated shall not be entitled to notice of the child's adoption proceedings, nor shall the parent have any right to object to the adoption or participate in the proceedings. No order terminating parental rights may disentitle a child to benefits due to the child from any third person, agency, state, or the United States; nor may it affect the rights and benefits that a Native American derives from descent from a member of a federally recognized Indian tribe. If, prior to the termination of parental rights, the parent was convicted of a crime against the child, the court may include in the termination order the requirement that the parent whose rights are terminated make a lump sum payment to assist in future financial support of the child.
