- **6.**I understand that by signing this surrender and release, I am voluntarily giving up all my parental rights to my child.
- 7.I have been advised that the court may approve my surrender and release *only* if the following conditions are met:
  - A. This surrender and release is being signed at least 72 hours after my child's birth, or, if the Indian Child Welfare Act applies to my case, at least 11 days after my child's birth pursuant to 25 U.S.C. § 1913(a) and 22 M.R.S. § 3946.
  - B. A licensed child-placing agency or the Department of Health and Human Services has offered and provided me counseling or offered counseling that I refused. This requirement does not apply if one of the petitioners seeking to adopt the child is a blood relative;

- C. The court has explained what my parental rights and responsibilities are, the effect of this surrender and release on those rights and responsibilities, and that **I have the right to revoke this surrender and release** within five working days;
- D. The court has informed me of the existence of the adoption registry and the services available under 22 M.R.S. § 2706-A;
- E. The court determines that this surrender and release has been duly executed and was given freely after I was informed of my rights; and
- F. The court determines that this surrender and release is in the child's best interest.

# 8.I understand that this surrender and release is final and irrevocable upon the court's approval.

**9.**In accordance with 18-C M.R.S. § 9-202, I hereby surrender and release my child for adoption and voluntarily relinquish all my parental rights and responsibilities to my child.
